

DECLARATION OF CONFORMITY

Product for direct contact with food

Description: GRILL BAGS - opaque, one side silicone treated natural greaseproof paper bags manufactured from virgin fibre with high chemical purity, with printing on non-treated side. For direct contact with food fits non printed paper surface. Single layer material.

Grammage (tolerance $\pm -5\%$) – 41 g/m², color – brown.

Product dimensions and packing:

AP300N 170x40x200 mm, 500 pcs in termo film and in carton box; Tolerance: Length ± 5 mm, gusset ± 2 mm, quantity $\pm 2\%$.

Purpose: direct contact with dry, moist and fatty foodstuffs, preparation of hot snacks in convection ovens up to a temperature 220°C, for use in microwave ovens a temperature of 150°C must not be exceeded.

Storage conditions: in original package, in a closed, well-ventilated area, away from direct sunlight and at least 1 m from the heat source, humidity up to 50% RH, temperature up to 25°C. Duration: 3 years, under proper storage conditions in not damaged package.

UAB "Amber Paper" hereby verifies that grill bags confirm requirements of the following legislation and could be used by application above:

- · Regulation (EC) No.1935/2004 on materials and articles come into contact with food with regards to raw materials and additives;
- · Hygiene standard HN 16:2011 of the Republic of Lithuania on materials and articles come into contact with food specific health safety requirements, confirmed by minister of health safety of the Republic of Lithuania from May 02, 2011 (No. V-417);
- Regulation (EC) 2023/2006 on good manufacturing practice (GMP) for materials and articles to come into contact with food;
- Directive 94/62/EC of the European Parliament and of the Council of 20th of December 1994, on packaging and packaging waste. This paper product is suitable by recovery by: material recycling (EN13430), energy recovery (EN13431), biodegradeable/compostable (13432);
- The silicone treatment is not considered as a plastic according to the Regulation (EU) No 10/2011 of 14 January 2011 on plastic materials and articles intended to come in contact with food, which excludes silicone materials from its application field;
- Follow the commission regulation (EU) 2017/1000 " AMENDING annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) as regards perfluorooctanoic acis (PFOA), its salts and PFOA - related substances;
- Printing inks (FL AquaFix 366479) are listed in the ordinance of the FDHA on Materials and Articles (817.023.21) in annex 2 (lists I and II of plastics) and annex 10.
